#### Notice of Race

##### **1 RULES**

The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.

##### **2 ENTRIES**

The event is open to all PHRF rated yachts. The race committee will assign provisional PHRF ratings to those boats without PHRF certificates. Scoring shall be PHRF time-on-time, using the formula  $CET=ETx(600/(480+PHRF))$ .

All boats race non-spinnaker. All boats shall have two crew.

Registration will be held in the Harlem Yacht Club starting at 11:00. The entry fee is \$20.00 US.

##### **3 NOTICES TO COMPETITORS & CHANGES IN THE SAILING INSTRUCTIONS**

Notices to competitors will be posted on the official notice board located in the Harlem Yacht Club. Changes to the Sailing Instructions shall be posted by 12:00.

##### **4 SCHEDULE**

A competitors' meeting shall be held at 12:00 on June 27<sup>th</sup>, 2015 in the Harlem Yacht Club. The warning signal for the first race will be at 13:00. Subsequent races will be held as soon as possible after the end of the previous race. A maximum of three (3) races will be sailed.

##### **5 SAILING INSTRUCTIONS**

The Sailing Instructions will be available at Registration and on the Harlem Yacht Club website.

##### **7 COURSES and MARKS**

The courses shall be windward leeward. The weather mark and number of legs will be displayed by the RC on the course board.

**8 PROTESTS**

Boats intending to file a protest or request redress shall notify the Signal Boat after finishing the race during which the incident occurred. This modifies RRS 61.3.

**9 POST-RACE PENALTIES and EXPEDITED HEARINGS**

US Sailing Prescription Appendix T - Alternative Procedures for Dispute Resolution, Sections B - Post Race Penalties and C - Expedited Hearings shall be used.

**10 SCORING**

The scoring of each series shall use Appendix A- Scoring. 1 race is required in order to have a series.
